- 5. The SWH loan applicant must be an active customer of WASAC and must have a regular water supply with sufficient pressure.
- 6. The SWH loan applicant must pay a non-reimbursable application fee equivalent to 30,000 Rwf on the project account number **100131735272** of EDCL SOLAR RWANDA PROGRAM located in Bank of Kigali (BK).
